ABOUT THE POSITION

The CLC Director's role requires a collaborative spirit combined with assertive leadership qualities, an entrepreneurial mindset and a proven track record in the cultural and creative industries.

The CLC Director South is one of the top leadership positions at EIT Culture & Creativity, responsible for the transnational region South. The CLC Director is a member of the Management Team and reports to the CEO of EIT Culture & Creativity. She/he represents EIT Culture & Creativity in the region, and manages relationships with partners and the CLC's daily operations. She/he is responsible for the execution of our Strategic Innovation Agenda in the region and accountable for the CLC's business plan.



In the set-up phase, the CLC Director is responsible for recruiting the team, setting up administrative structures and operational processes as well as building relationships with our Partners in the region - everything in close cooperation with the headquarters.

The CLC Director is a person who is able to connect with actors from different local and national ecosystems. This requires a mind- and skillset that effectively builds a diverse community to accelerate innovation. She/he must be able to build trusted relationships with partners from the industry, academia and creatives as well as scout for new technologies and entrepreneurial impact investment opportunities.

The CLC Director needs to have strong leadership and management skills and a relentless focus on results. We are looking for a community builder and a problem-solver with strong communication skills. We need a team player with effective negotiation and decision-making skills, who has an excellent understanding of and passion for developing and transforming the cultural and creative industries.

- Full responsibility for CLC legal entity and its financial sustainability
- Accountability for the CLC budget and the annual Business Plan
- Execution of CLC activities according to our Strategic Innovation Agenda
- Acquisition of non-EIT funding from private and public partners in the CLC regions
- Leading and coordinating financial, administrative, and legal issues at the CLC level
- Representing, positioning, and advancing EIT Culture & Creativity in the regional CCSI ecosystem
- Developing and operating a CLC as a successful organization
- Leading the strategic development of EIT Culture & Creativity in the CLC region
- Scouting for new technologies and innovations
- Generating deal flow and impact investment opportunities in scale-ups and spin-offs in cooperation with industry and academia
- Develop and lead the cooperation with the partners and network partners within the CLC including all the EIT Culture & Creativity members in the region represented in the Engagement Forum
- Manage the set-up phase and operations of the CLC and the CLC team
- Be responsible for the strategic communication of the CLC, especially during the set-up phase, building the reputation and brand of EIT Culture & Creativity within the regional ecosystem
- Work closely with the Management Team and other CLC Directors to ensure optimal synergies and deep integration of the entire organization
- Define, create, and grow maximum synergies and opportunities for new collaborations and activities.
- Co-create member services distributed by CLC together with other CLC Directors
- Responsibility for joint reporting and monitoring activities, required to fulfill EIT Culture & Creativity plans
- Develop and lead cooperations and partnerships with members and stakeholders within the regional CLC ecosystem, including business, academia, and government to accelerate responsible innovation and spread an entrepreneurial mindset in the regional Culture and Creativity ecosystem.



MANDATORY REQUIREMENTS

- A Master's level or higher degree in business or a science discipline, or equivalent professional qualifications
- At least 5-year experience in a leadership role managing a team (Director/ C-level or equivalent)
- At least 5-year experience in innovation ecosystems/ programmes and projects
- At least 3-year experience working in cultural and creative industries
- Business acumen and a proven track record in achieving financial sustainability with demonstrated experience in management in an international setting
- Strong experience in the development of engagement/customer/innovation/ and business strategies cultural and creative industries and a personal network in the sector/s
- Interaction with partners from at least two parts of the Knowledge Triangle (e.g. industry, SMEs, research labs, universities, government agencies, etc.), and partner relationships
- Proven ability to lead a team of professional staff and engage a broad array of individuals
- Excellent verbal and written communication skills in English and a regional / local language of the CLC
- Based on the European focus of the EIT Culture & Creativity the candidates should be residents in the European continent and must be allowed to receive the work permit needed for the job or secure the job provision by a company.

DESIRED REQUIREMENTS

- Experience in managing and operating a legal entity, including finance and legal matters.
- Strong experience with or within industry and legacy players (incumbent organizations in industry and academia)
- Strong experience in international collaboration and setting up new international projects, consortia, and alliances
- Knowledge of EIT KIC and/or equivalent international partnerships and networked communities
- Proven ability to create and accelerate start-ups and scale-ups, helping them access markets and raise private and/or public funds
- Expertise in cross-sectorial innovation projects
- Digital networking capacities, e.g. proven social media presence
- Knowledge of another European language(s).

- Ability to build trust and communicate with very diverse people and organizations
- Well-developed leadership and management skills
- Willingness to build a learning organization for an open ecosystem, integrating bottom-up as well as top-down management approaches.

The CLC Director will report to the CEO of EIT Culture and Creativity GmbH and will collaborate with the entire C-level Team and other CLCs Directors.
