#### Synopsis of position offered

The successful candidate will be part of the team responsible for the general installation and maintenance of the company's facilities, covering labs, stores and offices as well as assist the different departments with a variety of tasks. These responsibilities may include, but are not limited to:

- Installation work that may be needed in the Company's projects abroad.

# Requeriments

- Reporting directly to the Head, Site Installations & Commissioning, the position is demanding, requiring a person who is highly motivated, self-organised, possesses a high level of integrity and discipline with a strong work ethic and able to establish and maintain effective working relationships with the rest of the team.
- The selected person must be prepared to work to very tight deadlines in isolated and multi-functional projects and in conjunction with a team of international staff based at our head-office in Malta, as well as staff who are working at our foreign project sites.

- An electrical wiring licence B, and a track record of experience of successfully working with electrical, mechanical and plumbing equipment is a requirement.
